FMC Plans Long-Term Investment in Middleport Plant

FMC plans to make several capital improvements at the Middleport Plant as the company's Agricultural Solutions Division continues to experience steady growth within current business conditions.

FMC Middleport Plant Manager Noel Parker reports a major reason behind the improvements is the need to add capacity for newer products that are coming on line to meet increasing customer demands both in North America and internationally.

"This investment by FMC to accommodate these business demands is a very visible sign of the company's commitment to the Middleport plant, our workers, and our community," Parker said.

FMC Middleport serves as a formulations plant that mixes and packages products used to help grow the world's food supply. The plant provides products for nearly 100 different crops in more than 75 countries worldwide.

"At the plant, we are focused on both safety and flexibility, which means we have to make sure we respond quickly to changing environmental conditions," Parker said. "One example is a fungus that developed in California because of the drought and we had to adapt quickly to provide the customer with an important fungicide product."

"At this time, and given current business conditions, we expect long-term, steady growth of the FMC Middleport facility," Parker said, "and we are doing it in a sustained way with a keen focus on safety. Overall, this plant is a strategic piece of the agricultural products portfolio and therefore an important part of our long-term business strategy."

Ag Group Name Change

FMC's agricultural group name changed from Agriculture Products Group to Agricultural Solutions. FMC changed the name and focus to accommodate and provide more agricultural solutions to its customers.

"Our products allow customers and their crops to meet four important needs: To produce food, fill, fiber and fuel," said Plant Manager Noel Parker. "All of these areas are addressed with the products that are formulated and mixed at the Middleport plant."



Home Value Assurance Program

A homeowner that has resided in their home for more than two years, has soil sampling data and resides in areas that FMC remedial action, is eligible for the special FMC program.

How does the program work?

- Eligible residential properties are appraised based on condition of the property irrespective of any environmental sampling results or potential environmental remediation.
- An average of the appraisals becomes the home's HVA appraised price.
- · Homeowners can qualify for incentive payments, on a sliding scale, for sale up to one year from date of listing
- At the time of closing, FMC will pay homeowners the difference between the appraised price and the sale price.
